  - iii. **Treasurer/Administration** Waiting on obtaining documents from U.S. Army Corps in order to submit application to remove Randolph from floodplain designations, City on track with most income and expenses for current Fiscal Year, updating local business information on City website, NE Public Power District (NPPD) electric rates likely to increase this year, and engaging with Firstar Fiber of Omaha on potential recycling opportunities.
