ORDINANCE NO. 694

AN ORDINANCE OF THE CITY OF RANDOLPH, CEDAR COUNTY, NEBRASKA PROVIDING RULES AND REGULATIONS FOR STORAGE OF POISONOUS AND FLAMMABLE GASES BY AMENDING SECTION 7-301 OF THE RANDOLPH MUNICIPAL CODE; TO PROVIDE FOR THE REPEAL OF ANY ORDINANCE IN CONFLICT HEREWITH; AND TO PROVIDE FOR THE EFFECTIVE DATE THEREOF.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF RANDOLPH, CEDAR COUNTY, NEBRASKA, AS FOLLOWS:

Section I: That Section 7-301 of the Municipal Code of the City of Randolph be amended to read as follows:

7-301 <u>Poisonous and Flammable Gases</u>. Any person, firm, or corporation desiring to store or keep in the Municipality for any period of time any form of poisonous or flammable gas or liquefied petroleum gas in excess of one-hundred twenty (120) gallons or add to, enlarge, or replace any facility used for the storage of such gases must first get permission from the Governing Body. The Governing Body shall require the name of the gas, the place of storage, and the amount of gas stored. If permission is granted, the Governing Body shall prescribe such rules, regulations, and precautionary actions as they may deem necessary. Any such present use that is discontinued for a period of sixty (60) days shall not be revived without a permit. (Ref. 28-1229 RS Neb.)

Section 2: That all other ordinances or parts thereof in conflict herewith are hereby repealed.

Section 3: That this ordinance shall take effect after its passage, approval and publication according to law.
