Head Coach and Assistant Coach Code of Conduct

The Randolph Summer Youth wants to ensure that it provides its players, coaches, and parents with a positive, safe and rewarding baseball/ softball experience. By example of behavior, the coach of each Randolph team has a great impact on his or her team, the players' parents and other team supporters. The coach has an affirmative obligation to create a constructive, enjoyable and non-hostile environment in which the game is played. As the Randolph Summer Youth strives towards the most positive experience possible, we are committed to the following standards for our coaches. We ask each coach of every Randolph Baseball / Softball Team to read these standards and sign below to indicate his/her willingness to abide by them.

- 1. I will make the safety and welfare of each participant my number one priority
- 2. I will not consume alcoholic beverages and/or appear under the influence of same when dealing with children
- 3. I will not utilize or allow players to utilize tobacco products, including smokeless or chewing tobacco during games or practices
- 4. I will abide by a doctors decision in all matters of a players health and injuries and ability to play
- 5. I will treat everyone with respect regardless of race, sex, creed and ability
- 6. I will never use any physical means against players, spectators, officials or other coaches
- 7. I will not unduly criticize players. Any criticism I provide will be constructive in nature.
- 8. I will not criticize, aggravate, or incite the opposing team, coaches or fans by mouth or gesture
- 9. I will refrain from using profanity
- 10. I will know the rules applicable to my league and will abide by those rules at all times and have a copy of the League Rules with me at all practices and games
- 11. I will ensure that my team plays with the highest level of sportsmanship at all times and will not promote any actions that result in "running up the score" or otherwise embarrassing the opposing team
- 12. I will accept the decision of officials as being fair and called to the best ability of the official
- 13. I will raise any disputes I have regarding rules and their application or judgement calls in a dignified, brief and non-aggressive manner. To the extent satisfaction is not attained, I will simply play the game under appeal. I will make notice of any appeals to the rules to the Summer Youth Manager/Coordinator.
- 14. I will be responsible for the conduct of the players, coaches, parents and other supporters of my team members during games and practices and take reasonable action to secure their comportment with the principles of this Code of Ethics.
- 15. I will always do my best to make the experience fun for all participants

Violations of any part of this Coaches Job Description will be considered a serious matter by the Randolph Summer Youth Manager/Coordinator; violators could be subject to appropriate action, including separation from the Randolph Summer Youth Program. When a Parent/Coach/Spectator feels that there has been a violation of the Code of Conduct, an investigation by the Summer Youth Manager/Coordinator will be done. Reports of or disputes relating to possible violations will be brought to the attention of Summer Youth Manager/Coordinator for investigation and resolution.
